## **Unit Description:**

The unit focus is on both the individual and group processes of organizational behaviour. There are many aspects to organizational behaviour and this unit covers, motivation, teamwork and performance, the effects of different communication styles, types of conflict, leadership, and the skills for contributing to organizational effectiveness and effective change. In considering the organizational behaviour there are also cultural, ethical, and social concerns to be in taken into account.

## **Assessment Requirements:**

Assessment 1: Discussion Forum – On-Campus and Online	Week 1 to 8	10%
Assessment 2: Individual Reflective Essay:	Week 4	15%
Reflections on a global company specified by the lecturer should focus on the organisational behaviour theories discussed in this subject and student's goals and plans for personal and professional development in an organisational context. Students will explore the supplied article and submit online in Canvas a 1500-word essay related to applying the business communication theories discussed in the subject.		
Assessment 3: Group Project Report with Presentation:	Week 8	25%
The purpose of this assessment is to allow students the opportunity to choose a prescribed journal article in consultation and confirmation with the lecturer and demonstrate their understanding of the topic content from week 1 to 7. It is important that your chosen prescribed journal article will enable you to by proofread and edit a text by week 3.		(Report 20% plus presentation 5%)
Groups identify gaps in their chosen prescribed journal article before writing the report and delivering a presentation in which they describe and discuss alternatives.		
Groups of three or four must provide a 6000-word written report with an individual reflective summary report of 1500 words from each group member. Variations of plus or minus 10% of word limitation are acceptable.		
Assessment 4: Final examination (Closed Book). The 3 hours invigilated examination is conducted in the week 10 following the week 9 of study break and exam revision	Week 10	50%
